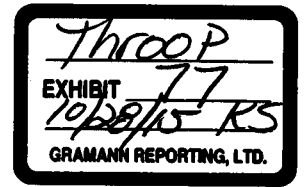

Dear Dr. Burton,

On January 5, 2015 Dr. Elizabeth Throop filed a formal complaint against you asking that I review and take action. I have attached the complaint and documentation. Under UWS 6.01 I have three options, 1) dismissing the complaint, 2) invoking appropriate disciplinary action, or 3) referring the complaint to the faculty complaints and grievances committee.

I have asked that Dr. Dominic Barraclough conduct a fact-finding investigation by speaking with you, with Dean Throop, and with anyone else that you, Dr. Throop, or he believes appropriate. Dr. Barraclough's role is strictly to gather information and not to give a recommendation or judgment. Once I have received Dr. Barraclough's report I will respond to the complaint. I have asked that Dr. Barraclough complete his investigation and submit his report no later than Monday, 2 February 2015.
