I am not surprised that UWP hasn't released my records to you yet. The HR Director informed me of your request. They assumed you were my attorney. I told them 'no.' Anything that has to do with me goes directly to Lattis. She is the one who controls what goes out and to whom. They deleted emails, manipulated records, changed my yearly evaluation after the fact ... I am not surprised. They can do it because there is no accountability, no oversight. I asked the DCI to look into public corruption here. I talked to Agent Peskie. He couldn't do anything because the AG's office handles their legal defense. Conflict of Interest ... So they get away with these things ... I am convinced that they got to my attorney as well. He is too experienced to misrepresent me so badly unless he did so intentionally. That is why people here just leave. "You can't fight them, you have no recourse against their abuse." They committed perjury and are getting away with it. My only hope is that this process hasn't been affected by the corruption yet. I was told not to expect much here either. It is frustrating.

Lattis & Co. have their hands in everything down here. My former colleague was blackmailed into resigning. That is a crime, isn't it? She is a single mom and had to leave abruptly and just days before school started for her boy. That was cruel. All that because she reported some misconduct as well. That is how they deal with you here. I will forward the email so you see how they work. No due process, no employee rights, no grievance hearings.

We can't even find an attorney who is willing to take them on here in Wisconsin. That is just so sad.

Attached an email in which Lattis stated to the grievance chair that she didn't intend to speak but she did speak toward the end of the recording and misinterpreted the law.

Oh, the Chancellor issued another letter of direction even though he still has not decided on the 6.01 Complaint against me yet. The report was issued to him by his "investigator" in early Nov. 2015 but he still holds my termination over my head like a "Damocles Sword." I have a prepared a rebuttal to his LOD and it probably would be good if you hear my side as well when you get their information. Again, I am getting punished for asking to have the false allegations in my previous LOD addressed and for asking for a grievance against a co-worker who has defamed me. Even the former HR director confirmed the defamation but the Chancellor and Lattis protect that person from reprimand. It was stated that I had a mental illness in public and in front of students. Dean Throop called me 'labile' at a meeting that Lattis attended as well.
