REVISED JOINT MOTION TO AMEND
PRELIMINARY PRETRIAL CONFERENCE ORDER

The parties, by their undersigned counsel, hereby revise and resubmit their joint motion (Dkt. # 16) to amend the preliminary pretrial conference order (Dkt. # 9) based on the following:

1. On January 8, 2015, counsel discussed the upcoming discovery deadlines and agreed to extend for both sides the deadlines for disclosure of experts, with Plaintiff's extended to mid-March 2015 and Defendants' extended to mid-May 2015. Defense counsel memorialized their agreement in a letter dated January 9, 2015. (Exhibit A).
2. Plaintiff is suffering from an acute medical condition which requires a medical procedure in March, 2015, and which required her to take a leave of absence from her work as of January 2015. Consequently, for a period continuing

through May, 2015, she will also be unable to participate actively in this litigation during the critical discovery phase.

3. On February 20, 2015, Plaintiff filed under seal her physician's confirmation of her medical condition (Dkt. # 18), pursuant to this Court's order of February 11, 2015 (Dkt. # 17).

4. Given Plaintiff's acute incapacity, the parties are unable to meet the Court's deadlines for disclosures of experts and dispositive motions.

5. Information regarding the nature of Plaintiff's medical condition has been shared with Defendants' counsel and based on that information they join this request.

6. Based on the foregoing, the parties jointly move the Court to adjust the litigation schedule in the preliminary pretrial conference order according to the following schedule and pursuant to the Court's trial calendar:

a. Disclosure of Experts: Plaintiff: July 31, 2015

Defendants: September 15, 2015

b. Deadline for filing dispositive motions: September 18, 2015

c. Settlement letters: February 26, 2016

d. Discovery cutoff: February 26, 2016

e. Rule 26(a)(3) disclosures and motions in limine: March 4, 2016

Responses: March 11, 2016

f. Final pretrial conference _____

g. Trial _____
