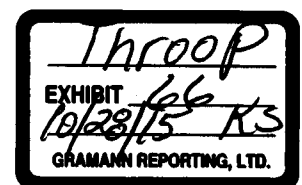

workforce competency levels in the public and private sector. According to the Federal Bureau of Investigation's Internet Crime Complaint Center in 2012 the States of Wisconsin, Illinois, and Iowa (the states that represent our Tri-State Initiative) reported in excess of 10,000 high level complaints in the year 2010 alone. A new study of 45 U.S. organizations found that cyber-crime, including Web attacks, malicious code and rogue insiders, costs each organization \$3.8 million per year, on average, and results in about one successful attack each week. The study found it took 14 days on average to respond to a successful cyber-attack, with an average cost to an organization of \$17,696 per day. Malicious insider attacks took up to 42 days or more to resolve (Network World, July 26, 2010). Typically, these crimes are driven to and by business and industry clusters. According to data provided by Michael E. Porter (2012) of the Cluster Mapping Project, the three highest employment markets in our regional area are local commercial services, local health services, and local hospitality services. Crime victimization data suggests that these clusters are often among the most targeted profit based enterprises for cyber- crime. This is significant as these clusters translate into the target markets for victimization and are markets that require educated cyber security and cyber- crime professional graduates. In addition, Janet Napolitano urged private security to step up their cyber-security efforts at the ASIS Conference in 2012. Currently the educational sector in the Tri-State area is not set up to supply the private and public sector with graduates who are educated and trained in cyber-security. The majority of UW-Platteville's Criminal Justice students aspire to work in the public sector, mainly law enforcement, corrections, and forensics. UW-Platteville already has one of the best Criminal Justice and Forensic Investigation programs in the nation. In order to maintain this status and respond to the demands of the private and public sector we have to provide homeland and cyber security training. Our cyber-security curriculum will be designed to educate our students in recognizing cyber-criminals, understanding their modus operandi, identifying and articulating what evidence should be seized, and preparing reports that will hold up in court. The curriculum will include the vulnerabilities of our public and private sectors, identifying security concerns and illicit activity, and methods to provide better private and public community and security agency services. Cyber security trained personnel provide a liaison between the more technical cyber community and traditional law enforcement agencies. Without this trained liaison cyber-criminals will continue to enjoy their head start and the problem will escalate. With this specialized training our graduates will be able to better recognize and pursue the perpetrators of cyber-crime, they will be better equipped to educate businesses and industry in ways to prevent future attacks and with a deeper understanding of this increasingly disruptive new form of crime will be better prepared to navigate legal and technical obstacles to convictions.
