I am primarily interested in the investigative side, not so much cyber-forensics, although my long-term plans are to also offer cyber-forensics as part of our Forensics Investigation major. Right now it is of great importance to produce police officers & detectives who understand how cyber-criminals work, how to trace them, what evidence to secure, how to properly write a search warrant for cybercrime investigation so evidence won't be thrown out on technicalities and how to put together a proper police report for this type of criminal activity.
